ORDER:

In the Government Order first read above, orders were issued according administrative sanction for the Irrigated Agriculture Modernization and Water Bodies Restoration and Management Project (IAMWARM) for Rs. 2547 Crore with the World Bank assistance for a period of six years from 01.04.2007 to 31.03.2013. This project is implemented for Rehabilitation and Modernization of System and Nonsystem tanks and their supply channels in order to increase the food production. The project is implemented from 2007 and it has been extended upto 30.09.2014.

2. In his letter second read above, the Project Director, Multi Disciplinary Project Unit has requested the Government to implement the activities for upscaling 400 model villages under TN IAMWARM Project in 17 Districts of Tamil Nadu in respect of Water Resources Department for an amount of Rs.1.40 Crore and this amount is to be met out from the savings due to increase in dollar exchange rates. The proposal covers 400 villages for which an amount of Rs.35000/- was proposed for each village. The World Bank has given its NOC on 26.06.2013 and the proposal has been approved by the Empowered Committee on 05.07.2013.

Further he has stated that the approach for upscaling model villages has been explained in detail in the concept note. The Empowered Committee has also approved the concept note. In the agenda notes approved by the Empowered Committee, it is indicated that the Secretary to Government, Public Works Department and the Engineer in Chief, Water Resources Department (at the HOD level) and the Executive Engineers, (WRD) are the Nodal Officers for implementing, monitoring, co-coordinating this programme. It is also mentioned that the Water Resources Department in the field and Public Works Department in Government will be the monitoring, coordinating and Nodal Department for this programme. He has requested the approval of the Government for the concept note for implementation of the above programme.

3. In his letter third read above, the Engineer in Chief, Water Resources Department, has requested the Government to accord Administrative Sanction for the following

- i) The concept note for proper Implementation of the programme.
- ii) Approval for Rs.1.40 Crore for Water Resources Department.
- iii) Engineer in Chief to add synergy to the above programme by dovetailing from the ongoing State/Government of India, programme wherever feasible (as per point 6 of the approval of the Empowered Committee in the approved agenda).

to implement the activities for Upscaling 400 Model Villages under IAMWARM Project in 17 Districts of Tamil Nadu.

4. Accordingly, the Government after careful consideration have decided to accept the proposal of the Engineer in Chief, Water Resources Department and as recommended by the Empowered Committee and accord administrative sanction for the following.

- i) Approval of the concept note for proper Implementation of the programme.
- ii) Sanction of Rs.1.40 Crore (Rupees One Crore and forty lakh only) for (Water Resources Department) implementing and Upscaling 400 Model Villages programme under TN IAMWARM Project.
- iii) Engineer in Chief to add synergy to the above programme by dovetailing from the ongoing State/Government of India, programme wherever feasible (as per point 6 of the approval of the Empowered Committee in the approved agenda) to implement the activities for Upscaling 400 Model Villages under IAMWARM Project in 17 Districts of Tamil Nadu.

5. The expenditure sanctioned in para 4 above shall be debited under the following Head of Account.

The Engineer-in-Chief, Water Resources Department is requested to send necessary proposals to Government in Finance (BG-I) Department in the prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate to the Finance (BG-I) Department at an appropriate time.
