ORDER:

In G.O.(Ms.) No. 317, Public Works (W2) Department, dated 28.10.2008, orders were issued sanctioning Rs.632.30 lakks for formation of Participatory Irrigation Management Cell and to conduct Election for the Water Users' Associations (WUA).

- 2. Tamil Nadu Farmers' Management of Irrigation Systems Act and Rules empower the District Collectors to make arrangements for conducting election for the constitution of Managing Committees of the Farmers Organisations.
- 3. The Tamil Nadu Farmers Management of Irrigation Systems Act and Election Rules 2003, does not provide for collection of deposits from contesting candidates, appointment of election agents, polling agents and counting agents and for payment to the polling personnel.
- 4. With due consideration of the above aspects, the Government hereby prescribe the following guidelines for the smooth conduct of elections to the Farmers Organisation:-
- (1) The Collectors of the respective districts shall arrange to appoint Election agents, Polling Agents and Counting Agents for the conduct of Election to Farmers Organisations. Necessary Forms A, B & C have been prescribed for this purpose in Annexure to this order.

- The Collectors of the respective district shall allow the Returning Officers to (2)collect the non-refundable deposits at the rates prescribed in the Annexure-D to this order either by means of direct payment by cash or by submitting a chalan for remittance of the deposit in appropriate Government account and shall maintain necessary accounts in this regard.
- (3) The Collectors of the respective district shall remit the deposits received in cash from the contesting candidates in the following deposit head of account. The contesting candidates who desire to remit the deposit directly in the Treasuries should also be requested to remit the deposits in the following head of account:
 - "0701. Major and Medium Irrigation 80. General , 800 Other receipts. AH. Receipts from the contesting candidates for Water Users' Associations Election." (DPC 0701 80 800 AH 0004).
- The Collectors of the respective District shall arrange to make payment to the Polling personnel as remuneration at the rates mentioned in Annexure - E to this order.
- The Collectors are requested to strictly adhere to the above guidelines for the smooth conduct of Elections to Farmers Organisations on or before 27.12.2008. -
- This order issues with the concurrence of Finance Department vide its U.O. No. 13/DS(VP)/2008 and Dated 05.12.2008.
